Because JPEC keeps personal information on file such as social security numbers and credit card number, information security has become a top priority at JPEC. For example, every computer at JPEC's corporate office requires a complex password as well as a physical ID badge before it can be turned on. Further, only certain members of

JPEC's staff have access to sensitive account information.

In addition to the measures JPEC is taking in the office, the company will be stepping up efforts when working with members. Account information will no longer be provided to members' whose name is not listed on the account. In the past, JPEC has been understanding when, for example, a husband calls for information and only his wife's name is listed on the account. Moving forward, this will not be the case. Please check your account information and let a customer service representative know if you would like someone other than who is listed on the account to have access.

And, keep in mind, JPEC will never call you and ask for personal information. Keep your private information private. If you didn't initiate the call or if you are unsure of the caller, ask for a name and call back to be sure you are talking to who you think you are talking to.

The Board Report

The following items were approved at the Aug. 28, 2008, regular board meeting: a consent agenda including minutes of the July board meeting, the July Operating Report and the board of directors' fees and expenses for July.

The board heard a report from JPEC's representatives on the Big Rivers Electric Board and a report from the Kentucky Association of Electric Cooperatives Board Meeting. In addition, reports were presented by JPEC's vice presidents and the president/CEO.

The board reviewed a plan for JPEC to host the 2009 Lineman Rodeo. The Rodeo is held annually and highlights safety and line worker skills. The board approved the proposal to hold the event at JPEC.

Board meetings are normally held the fourth Thursday of the month. August's board meeting will be held on Oct. 23, 2008. Members wishing to address the board must contact the CEO's office at least seven working days prior to the meeting.
