



# 2019 JPEC \$1,000 Scholarship Application

Jackson Purchase Energy Corporation's college scholarship program is part of its Power to Students campaign and one aspect of JPEC's continuing effort to further the education of the region's students.

The scholarships awarded may be used at any accredited Kentucky university or community college and for any course of study in the curriculum.

To qualify:

- You must be enrolled currently as a senior at a local high school or home school and plan to enroll in a full-time course of study (12 hours per semester) at an accredited Kentucky university or community college no later than the fall semester of the year in which the scholarship is awarded.
- Your primary residence must be served by JPEC.
- You must have a GPA of at least 3.0 and an ACT score of 18 or higher.
- You must attend Jackson Purchase Energy's annual meeting on June 18, 2019.

**The application must be received by 4 p.m. on Friday, March 1, 2019:**

- **A completed, typed application.**
- **A brief, typed narrative stating your reason for applying for the scholarship. The narrative should include any special needs (financial or otherwise) and your plans for the future.**
- **An official signed school transcript of courses and grades to date.**

Scholarships are given for one school year, allocated evenly over two semesters. To receive the second allotment, you must provide proof of a full study course (12 hours or more) and a GPA of 2.5 or higher (on a 4.0 scale). Funds are paid directly to the university or community college of choice.
